

# Security Compliance Software (continued)

## Security Compliance Software Definition

Security compliance software helps companies document their compliance with cyber security frameworks in order to pass security audits. These tools enable information security or compliance teams to evaluate and manage their security processes. This helps ensure they comply with internal controls and industry or regulatory security frameworks such as SOC2, PCI DSS, ISO 27001, ISO 27002, FedRAMP, NIST 800-171, NIST 800-53, and NIST Cybersecurity Framework, among others. These tools enable security and compliance analysts to assess company systems and policies and document or identify areas of compliance and noncompliance.

Undergoing a security audit can be both time-consuming and an internal resource-intensive endeavor. This software can ensure gathering compliance information is collaborative, correct, complete, and in the format required by auditors.

There are some similarities between security compliance software and [GRC platforms](#), but GRC platforms focus on identifying financial, legal, and all other liabilities, not cyber security risks. There is some overlap between security compliance software and [cloud compliance software](#), as the latter offers continuous infrastructure monitoring to identify security risks, which can be a component of automated evidence collection in security compliance software.

To qualify for inclusion in the Security Compliance category, a product must:

- ▶ Offer pre-mapped and up-to-date templates for security frameworks such as SOC2, ISO 27001, and PCI-DSS, among others
- ▶ Collect security compliance evidence and other documentation either through guided workflow or automation via system integrations
- ▶ Conduct risk assessments and provide risk mitigation insights
- ▶ Generate reports using predefined templates

## Enterprise Security Compliance Grid® Scoring Description

Products shown on the Enterprise Grid® for Security Compliance have received a minimum of 10 reviews/ratings in data gathered by February 25, 2025. Products are ranked by customer satisfaction (based on user reviews) and market presence (based on market share, seller size, and social impact) and placed into four categories on the Grid®:

# Grid® Methodology

## Grid® Rating Methodology

The Grid® represents the democratic voice of real software users, rather than the subjective opinion of one analyst. G2 rates products from the Security Compliance category algorithmically based on data sourced from product reviews shared by G2 users and data sourced from third parties.

Technology buyers can use the Grid® to help them quickly select the best products for their businesses and to find peers with similar experiences. For sellers, media, investors, and analysts, the Grid® provides benchmarks for product comparison and market trend analysis.

## Segmented Grid® Scoring Methodology

When viewing a Grid® by segment size, the same Grid® scoring methodology applies. However, the review data used is only from reviewers who are employed by a company within a particular company segment.

G2 uses the following definitions for company segments:

- ▶ Small-Business Review: A review from someone who works at a company with 50 or fewer employees
- ▶ Mid-Market Review: A review from someone who works at a company with 51-1,000 employees
- ▶ Enterprise Review: A review from someone who works at a company with 1,001+ employees
